WHEREAS GSU recognizes the importance of participating in local, regional and national committees;

WHEREAS members who are involved in a committee at work or in their community should have the opportunity to attend conferences and seminars related to their portfolio;

WHEREAS the current selection process favors National Officers to the detriment of other members that might be more involved in the area of interest;

BE IT RESOLVED THAT GSU revises the criteria for selection priority;

BE IT FURTHER RESOLVED THAT Regulation 12 be amended as follows:

Regulation 12 - Selection of delegates for Conferences and Seminars

Delegates to Conferences and Seminars will be determined by the GSU National President and the National Vice-President with the responsibility for the relevant portfolio. The criteria for selection priority of delegates shall be;

- a) National Officer with an or assigned role in their region
- b) Local and Regional positions with an assigned role and activities both (NOTE: NOT APPLICABLE IN FRENCH) within GSU, PSAC, and/or community
- c) General Membership

Consideration will be given based on the merit of the application.

Regional distribution shall be a consideration. The National President will consult with the respective Regional Vice-Presidents in the applicant's jurisdiction for input on selection. GSU will strive to rotate opportunities to Members when selecting delegates to conferences and seminars.

Regulation 5 – GSU Standing Committees

- 1. Each Committee shall ensure to have terms of references. The format of the terms of references should follow the template available on the GSU website.
- 2. At the beginning of each new cycle, the Chair of the Committee shall ensure that the terms of references are reviewed and updated.
- 3. At the beginning of each new cycle, each Committee shall ensure to have clear objectives for the next three years.
- 4. The Chair of each Committee shall submit to each scheduled annual National Council meeting a written report on the activity of the Committee since the last National Council meeting.
- 5. Ad-hoc Committees are not subject to this Regulation.

h) Young Workers Committee

Brother Bruce Roy National Vice-President tabled a report on behalf of the Committee. Brother Roy read the report of the GSU Young Workers Committee to National Council. He stated that the summit was a great success and that they were able to recruit members to get more involved with their locals and union within their regions.

Whereas Young workers will be a source of new ideas and resolutions, and GSU needs to include younger workers' visions and priorities in its own priorities; and

Whereas Young workers should be invited to become involved with the Union; and

Whereas GSU held a successful Young Workers Summit in 2019; and

Whereas Young Workers at the Summit were very engaged and shared a lot of insightful information; and

Whereas GSU needs more ways to include and attract volunteers; and

Whereas A forum where young workers gather gives more results than a Committee.

Be it resolved that GSU hold a Young Workers Summit every three years, in the year before the GSU Triennial Convention; and

Be it further resolved that this is a two-day Summit to be held in the National Capital region and will include six (6) GSU Young Workers in good standing from each employer group, the National President and a National Vice-President.

Note: This resolution will be forwarded to the Finance Committee for a costing and this will be presented at the next National Council meeting in April 2021 and will be included into the budget.

Brother Howard thanked Brothers Roy, and Hanson, as well as the members of the Committee, Sisters Barrette and Thomas for work they did with the Committee.

7. Other Business

b) Location of National Council Meeting in 2021

After some discussion it was decided that the next National Council meeting in April 2021 will be held virtually. Sister Thomas will be sending an email to National Council requesting feedback.

8. Business arising from the previous minutes

Actions to be taken:

a) Standing Discipline Committee

Brother Howard advised National Council that the GSU Standing Discipline Committee is composed of five members. At the present time, GSU only has two members: Sisters Babcook and Doucet. He also provided information on the duties and responsibilities to be part of this Committee.

- There must be at least three members on this Committee;
- Must take training provided by PSAC;
- Must be a member in good standing.

Sister Doucet also added the following information:

- Requests for investigation are usually sent to the PSAC National President and then forwarded to the Component for investigation;
- If GSU does not have enough members on the SDC, they can reach out to other Components;
- If you know the member being investigated, you must withdraw from being on the Committee, as you must remain impartial.

Brother Howard indicated that he is looking for volunteers to be part of this committee, as he does not want to appoint anyone. After some discussions the following National Council Officers submitted their names and volunteered to be part of the Committee and to commit to the training offered by the PSAC.

Names submitted: Sisters Kelly Bush, Sue Boone, (Alternate) Azra Jusuf, Leanne Moss, Michèle Parent, Brothers Kevin Hanson and Pascal Ladouceur. Should you wish to be part of the Committee, you can also send an email to Brother Howard. Brother Howard thanked the National Council members for their interest.

b) Terms of Reference (TOR) Standard Framework across the country

Discussions took place on Standard Framework (TOR) across the country. Brother Howard also had discussions with his National Vice-Presidents on this topic. He advised National Council that this is a very difficult task to accomplish to have the

TOR standard across the country. For some regions, meetings with other bargaining units are benefcial. He stated that this format works very well in the Quebec region. Sister Harding indicated that she is not opposed to having other bargaining units participate in regional meetings, but not as co-chairs. Sister Stein echoed Sister Harding's comment. Brother Howard indicated that he would not have any issues to reach out to the Regional Director for the Pacific Region. He also stated that he would like to have future discussions with Sisters Harding and Stein. Brother Howard requested feedback to find out how the other regions proceeded with their regional meetings.

Quebec Region: Sister Parent advised National Council that Local Presidents can attend the regional meetings and this is a very good learning curve, part of their training and it is beneficial.

Atlantic Region: Brother Drozdowski stated that Local Presidents cannot attend.

Ontario Region: Sister Jusuf stated that Local Presidents cannot attend.

National Capital Region: Brother Hanson stated that Local Presidents can attend some meetings. Brother Roy clarified that in the NCR there are no regional meetings, just Local meetings.

Western Region: Sister Rawlins stated that it works well in her region. Sister Williams added that Local Presidents can attend and that they have 3 co-chairs, PSPC, GSU and PIPS.

This does not apply to the Royal Canadian Mint.

Brother Howard will leave this to the regions and Locals to decide what works best for them as the TOR's are different across the country.

c) Update Mental Health (Support from GSU)

Brother Howard informed National Council that he is looking into types of training that can be provided on Mental Health and how to support National Council. He has also reached out to other Components to find out what they are doing but he has not received any responses.

Sister Parent stated that Mental Health training should be educational, that we need to take care of ourselves and that we need the proper support from GSU. Mental Health training is one issue but it's not just about training. GSU needs to be more involved supporting elected officers and members. She stated that her executive is newly elected, they have no training and it is very difficult for them to be released to do union business / activities. This is a major concern and GSU needs to negotiate with Human Resources for more flexible time for union activities.

Sister Bush echoed Sister Parent's comments and that as an organisation, we need to do more to protect our officers. Sister Bush recommends having more discussions on this topic at our next meeting. She will work on a framework.

9. Round Table

The meeting ended with a round table discussion. Due to lack of time, only National Council members that had comments addressed National Council.

Sister Doucet: She informed National Council that she was contacted by the Director of Pay and Administration Branch requesting a list of contacts in each Local. She was advised by the DG that some members do not know which union they belong to. Brother Howard stated that he has no issues with Sister Doucet providing the contact information and that she could coordinate with the Regional Vice-Presidents.

Sister Harding: She advised National Council that she will be attending the BC Federation of Labour Conference on November 25 and 26, 2020 and that the Health and Safety Conference is scheduled from March 19 to 21, 2021. Both meetings will be held virtually.

Brother Howard invited the observers to address National Council.

Brother Tait: He stated it was his first time attending a National Council meeting and that it was an "eye opener". He thanked National Council for inviting him.

Brother Colterman: He thanked everyone for their hard work and for being able to participate.

Sister Lima: She thanked National Council for inviting her.

Brother Howard: He thanked everyone for their time and hard work. He also informed National Council that Local 10161 and Local 50057 held virtual Annual General Meetings and that they were very successful. He thanked Brother Manchester for helping the Locals organizing their AGM virtually. He thanked the staff, the interpretation and Electronic Language Communications for a successful meeting.

I am pleased to present the National Council with the last GSU By-Laws Committee report for the 2018-2020 cycle. This also is my first report as the Chair of Committee, following Brother David Cunning's departure.

I would like to first start by providing the National Council a summary of the By-Laws activities over the last 2 ½ years.

Under the leadership of Brother Cunning:

- The Committee met in September 2018 to go over some By-Laws changes that were ruled out of order by our National President as they were deemed substantive changes rather than editorial.
- In February 2019, the National Council voted in favor of the recommendations of the By-Laws Committee to rule those changes out of order.
- In August 2019, the Committee met again and started reviewing the By-Laws, Regulations and Policies for potential resolutions ahead of the 2020 Convention.

Finally, in preparation for the National Council of April 2020, the Committee met in February 2020 for a two-day meeting to draft resolutions on potential amendments to the GSU By-Laws, Regulations and Policies. In the following pages, you will see the results of the Committee's work.

Firstly, you will be presented with a series of By-Laws amendments that the Committee would like to bring forward to Convention. As you know, By-Laws can only be amended by a 2/3 majority at Convention. In order to get there, we first need the National Council's support to submit those resolutions to Convention.

Secondly, you will find proposed amendments to some Regulations and Policies. These changes can be adopted by the National Council and will take effect upon adoption. National Council already adopted two changes to the Regulations and Policies in August 2019 and changes adopted during the April 2020 National Council will be added

to the list for ratification at Convention. Once again, the Committee is asking that the National Council support the recommendations of the Committee.

On a personal note, I would like to thank the members of the Committee for their work and contribution. You raised very interesting points and your interventions throughout the exercise were always on point. The National Council is very fortunate to have a strong and dedicated By-Laws Committee.
