# **GSU GOVERNANCE**

## NATIONAL COUNCIL MEETINGS OPEN TO OBSERVERS

## RESOLUTION 99/09A - ADOPTED GSU 1999 CONVENTION

**BE IT RESOLVED THAT** all National Council meetings be open to Local observers with voice but no vote.

**BE IT FURTHER RESOLVED THAT** all members who wish to observe a National Council meeting must so advise the National President at least two (2) weeks prior to the meeting.

**BE IT FURTHER RESOLVED THAT** in normal circumstances, one observer per Local in the immediate area of each National Council meeting location may have their expenses paid by the union in accordance with Regulation 4.

## LOCATION OF NATIONAL COUNCIL MEETINGS

#### RESOLUTION 99/10 – ADOPTED 1999 GSU CONVENTION

**BE IT RESOLVED THAT** our Union's National Council meetings be held in the various regions across the country where we have members (by rotation).

# FINANCE COMMITTEE RECOMMENDATION — ADOPTED 1999 GSU CONVENTION

The Finance Committee recommends concurrence in the proposal that the new union have a percentage dues structure.

## **ANNUAL GENERAL MEETING ALLOWANCE**

#### RESOLUTION 99/83A - ADOPTED 1999 GSU CONVENTION

**BE IT RESOLVED THAT** an annual allowance of \$100 be given to Locals with 100 members or less to offset the cost of an Annual General Meeting. Each qualifying Local must submit a request for the subsidy to the National Office.

In April 2021, National Council amended GSU Policy 15 to increase the allowance to \$500. This amendment was ratified by the 2021 GSU Convention.

## TWO LOCAL PRESIDENTS' COUNCIL MEETINGS

#### RESOLUTION 05/19 - ADOPTED 2005 GSU CONVENTION

**BE IT RESOLVED THAT** the National President will convene two meetings of the Local Presidents' Council which will make recommendations to the National Council. The National Council meeting for that year will be held immediately after the Local Presidents' Council meeting.

**BE IT FURTHER RESOLVED THAT** one of these two meetings be held two years before the GSU Triennial National Convention, and the second of these two meetings be held the year before the GSU Triennial National Convention.

2021 GSU Convention amended GSU By-law 11 to replace *Local Presidents' Council* by *Local Presidents' Conference*.

## LOCAL PRESIDENTS' ROLE IN GSU GOVERNANCE

### RESOLUTION 11/23 – ADOPTED 2011 GSU CONVENTION

**BE IT RESOLVED THAT** this Convention recognizes that Local Presidents may be appointed to GSU standing committees by the National President and that Local Presidents may participate at regional labour-management committees or their equivalent in the NCA at the call of the appropriate Regional Vice President.

**BE IT FURTHER RESOLVED THAT** each annual meeting of the Regional Vice Presidents and Local Presidents will report to the next GSU Local Presidents' Council. These reports may raise issues of concern to the Locals which may be discussed at the Local Presidents' Council.

## **GSU Accommodation Fund**

#### RESOLUTION 11/27 - ADOPTED 2011 GSU CONVENTION

**BE IT RESOLVED THAT GSU** create a fund that Locals may apply for economic assistance for the purposes of accommodating members with disabilities, and

**BE IT FURTHER RESOLVED THAT** this fund be used for Local decision making, union representation and union education.

## **NATIONAL VICE PRESIDENT ELECTIONS**

#### RESOLUTION B 09-14 - ADOPTED 2014 GSU CONVENTION

**BE IT RESOLVED THAT** the National Vice President positions will be elected separately, starting with the NVP Equity position.

## CONSULTATION WITH LOCALS ON REGULATIONS AND POLICIES

#### RESOLUTION G 16-14 - ADOPTED 2014 GSU CONVENTION

**BE IT RESOLVED THAT** the National Council should consult with each Local on any change(s) to the GSU Regulations and Policies before the National Council decision and/or vote take place.

## **RVP JURISDICTIONS**

#### RESOLUTION B 04-17 - ADOPTED 2017 GSU CONVENTION

**BE IT RESOLVED THAT** RVPs be allowed to represent members in their jurisdiction as well as other jurisdictions at the request of another RVP or the National President.

## LOCAL TO LOCAL MENTORSHIP AND SUPPORT

## RESOLUTION G-17-23 - ADOPTED BY 2023 GSU CONVENTION

**BE IT RESOLVED** that at the discretion of local and/or a local's governance structure activists from other locals can provide assistance to aid in the support of a local to fulfill their responsibilities and/or support activists participation within the union.

# UNION-MANAGEMENT AGREEMENTS ON WORKPLACE HEALTH AND SAFETY

### RESOLUTION 02/51 - ADOPTED 2002 GSU CONVENTION

**BE IT RESOLVED THAT** any union-management agreement on WHS respects as a minimum the common rules established by the Canada Labour Code.

#### GRIEVANCE TRACKING

#### RESOLUTION 08/44 - ADOPTED 2008 GSU CONVENTION

**BE IT RESOLVED THAT** GSU acquire and implement "Unionware" as our grievance handling and tracking system for all levels of GSU representation.

#### **EMPLOYMENT SECURITY**

#### **EMERGENCY RESOLUTION - ADOPTED 2011 GSU CONVENTION**

**BE IT RESOLVED THAT** Convention affirms employment security for all GSU members as GSU's highest priority and authorizes National Council to access funds from the GSU Contingency ("Fight Back") Reserve to achieve that objective.

## **PSYCHOLOGICAL HEALTH**

## RESOLUTION 11/32 - ADOPTED 2011 GSU CONVENTION

**BE IT RESOLVED THAT** GSU shall lobby employers so that the importance of preventative action in psychological health is recognized and sustained.

## **DUTY TO ACCOMMODATE**

#### RESOLUTION G 09-14 - ADOPTED 2014 CONVENTION

**BE IT RESOLVED THAT** GSU takes steps to ensure adequate processes are in place to deal with workplace accommodation issues.

## Union activities agreements for Local officials

## RESOLUTION G 01-17 - ADOPTED 2017 GSU CONVENTION

**BE IT RESOLVED THAT** GSU negotiate, in consultation with Locals, with Department(s) (if there is more than one) Union Activity Agreements paid for by the employer(s) in question for the Local officials, and

**BE IT FURTHER RESOLVED THAT** GSU, through its Regional and National Vice-Presidents network, provide the necessary coaching and support to Locals who need it, to maintain and support their officials' autonomy. Those officials would be given time off and be remunerated by the employer(s).

## CANADIAN LABOUR COLLEGE

#### RESOLUTION 99/84 - ADOPTED 1999 GSU CONVENTION

**BE IT RESOLVED THAT** this Union support the Canadian Labour College with an annual donation of \$1000.00.

## **AREA COUNCIL FINANCING**

#### RESOLUTION 02/49 - ADOPTED 2002 GSU CONVENTION

**BE IT RESOLVED THAT** our Component donate one hundred dollars (\$100.00) per year, per Local, to the Area Council to which each Local belongs, with funding to come from unallocated funds.

#### CHAMPIONING ABORIGINAL ISSUES

#### RESOLUTION G 18-14 - ADOPTED 2014 GSU CONVENTION

**BE IT RESOLVED THAT** Government Services Union consult with the National Aboriginals Circle to find out how we as a Component can best champion aboriginal issues and be allies to their fights and campaigns.

## TYPOGRAPHICAL AND EDITORIAL CORRECTIONS

#### RESOLUTION 02/30 - ADOPTED BY 2002 GSU CONVENTION

**BE IT RESOLVED THAT** the National President have the authority to correct typographical and editorial errors before the By-Laws are reprinted after Convention, ensuring there is no change to the intent of any By-law.

**BE IT RESOLVED THAT** GSU develop an orientation information presentation for consistent communication to new members that may be delivered in a timely, efficient and knowledgeable manner.

## RESOLUTION G-1-21 - ADOPTED BY 2021 GSU CONVENTION

**BE IT RESOLVED THAT** each GSU standing committee includes a young worker wherever possible.

**BE IT FURTHER RESOLVED THAT** the GSU Equity Committee has a young worker member from an equity group.

## **BUILDING EQUITY IN THE UNION**

#### RESOLUTION G-2-21 - ADOPTED BY 2021 GSU CONVENTION

**BE IT RESOLVED THAT** each GSU standing committee includes an equity group member wherever possible.

## MENTAL HEALTH TRAINING FOR ELECTED OFFICERS

#### RESOLUTION G-14-23 – ADOPTED BY 2023 GSU CONVENTION

**BE IT RESOLVED** that GSU offer mental health training available to all elected representatives once per cycle.

## **GSU MENTORING PROGRAM**

#### RESOLUTION G-32-23 - ADOPTED BY 2023 GSU CONVENTION

**BE IT RESOLVED THAT** GSU develop and offer a mentoring program for delegates and Local Officers funded by the existing budget, that is, comprehensive ongoing training in labour relations with the following suggested components: health and safety, staffing, classification, performance management, disability, legislation, understanding the collective agreement, grievances, values and ethics, conflict resolution, and others without limit.
