Brother Howard provided an update on the GSU Bursaries. He informed National Council that Public Services and Procurement Canada (PSPC) has agreed to post the notification "In the Know", Shared Services Canada (SSC) has also agreed to post the notification and the Royal Canadian Mint (RCM) will be sending an email to all employees. Sister Harding advised National Council that PSPC had already posted the notification.

8. New Business

Remarks

Q. Sister Hamel requested clarification on how to submit an expense claim for attending GSU Union Leave Meetings.

A. Brother Howard indicated that expense claims for \$50 are to be submitted for any union meetings attended.

Brother Howard: He informed National Council that PSAC sent a memo regarding mandatory vaccinations in the workplace. At the present time, the vaccine is not mandatory, and a decision will be rendered after the federal election. GSU is working closely with PSPC and SSC to ensure that a proper protocol is in place. Brother Howard is waiting to receive the directive from Treasury Board. However, the goal is to keep the workplace healthy and safe.

Sister Harding: She expressed concerns on staffing policies in the BC region. Members should be able to apply for competitions regardless of geographical location.

Sister Stein: She echoed the same concerns. Geographical location should be removed when applying for a competition.

Sister Hamel: She reiterated the same concerns. She stated that when face-to-face meetings occur members are requested to pay for their own travel and accommodations.

Overall, National Council expressed their concerns regarding mandatory vaccinations and geographical location for hiring. Brother Howard indicated that he would take into consideration all comments received and will bring these concerns to PSAC and Treasury Board.

Sister Doucet: She expressed concerns on the lack of information that they receive from the National Office regarding National Health and Safety Policy Committee (NHSPC) meetings. Many members of National Council echoed sister Doucet's concerns.

Brother Drozdowski: He requested that Regional Vice-Presidents attend the NHSPC as observers. Brother Howard will follow-up.

National Council members made it very clear that they need to be kept informed on what emerges at NHSPC meetings.
