Sister Boone reminded everyone that while it is important to visit different areas across the country, to keep in mind that locations need to be fully accessible.

7. Round Table

The meeting ended with a round table discussion:

Sister Babcook: She was unable to attend the previous National Council meeting and requested an update regarding the vaccine discussion. She wanted to know why GSU's position had changed. Brother Roy indicated that GSU requested legal opinion and that National Council agreed that GSU file grievances for members who refused to get vaccinated for personal reasons and the grievances would be placed into abeyance. This is to ensure that the deadlines are protected.

Sister Fillion: She stated that the letter sent by email to Local Presidents was not very clear and Local Presidents do not have a clear understanding of GSU's position on the vaccine. Sister Fillion requested that GSU schedule a conference call with the Local Presidents to explain the process and answer questions.

Sister Boone: She commented that since this will be a "case by case" approach, we need to ensure we gather as much information as possible from the members. She also stated that members could file a complaint with Human Rights. She wished everyone a happy holiday season and to stay safe.

Brother Hanson: He advised National Council that he shared via chat a link to the jurisprudence, and this may assist members to generate some thought on the subject and help better understand.

Brother Drozdowski: He had questions regarding reclassification and that the employers are trying to merge groups with the PA. He wanted to know if the unions have been included in the consultation meetings and requested regular updates and discussions (standing item on NC agenda).

Brother Roy indicated that he would defer to Brother Girard, and that a meeting would be scheduled.

Sister Barrette: She reminded National Council that the National Office has launched a monthly "Lunch and Learn" series. Live sessions are hosted on Zoom every month and recordings of the sessions will be published on GSU's YouTube channel afterwards. She also notified National Council that they will be receiving emails in the new year in preparation for the workshops for the retreat.

Sister Barrette (for Sister Desrosiers): She reminded National Council to submit their expense claim for today's meeting and reminded that some National Council members did not submit their claims for Convention and to do so.

Brother Roy: He reminded National Council to book their travel for the National Council Retreat that will be held at the end of January. Brother Roy advised National Council that GSU now has adopted a workplace harassment prevention policy and that a copy was shared with staff and that he will be providing National Council with a copy by email.

He thanked the Interpreters, Encore, staff and National Council for a job well done. He wished everyone a safe and happy holiday season and is looking forward to seeing everyone in person in January 2022.
