# **Purpose of the Meeting – Vaccine Mandate**

Brother Roy indicated that the virtual conference call was an informal information session to advise National Council of the latest developments on the vaccine mandate. He also stated that simultaneous interpretation will not be provided at this meeting. However, Brother Roy will conduct the meeting in both official languages.

## **Summary of discussion**

- Based on numerous exchanges between GSU and PSAC and new information received, GSU's position has changed.
- GSU requested legal opinion from an independent law firm, and it was strongly recommended that GSU file grievances for members who have been suspended and are on leave without pay.
- National Council agreed that GSU should be filing grievances for members who refused to get vaccinated for personal reasons.
- Brother Girard indicated that the grievances are to protect time limits and grievances will be placed in abeyance pending further information from PSAC and upcoming arbitration decisions.
- The deadline to file a grievance is December 10, 2021. Brother Girard indicated that it is best to use an earlier date to protect time limits.
- PSAC is planning on changing their position regarding members who have longterm telework agreements.
- Brother Girard indicated that GSU communicates regularly with PSAC and PSAC representation.
- National Council requested that GSU reach out to the membership and advise them of these changes.
- Brothers Roy, Girard and Sister Barrette will meet after the zoom session to discuss the best way to communicate this information to GSU members.
- Some members of National Council indicated that all meetings should be provided with simultaneous interpretation. (Formal and Informal meetings)
- Sister Parent stated that she was very happy that GSU is supporting its members.
- Brother Roy indicated that the goal is to keep National Council informed. He thanked everyone for participating.
- Next conference call is scheduled for December 10, 2021 and Brother Roy is looking forward seeing everyone!
