Call to Order

- Sister Lackie called the Seventh GSU Triennial National Convention to order at 9:00 a.m. on Tuesday September 26, 2017.
- The Convention started with a drum recital called 'djembe' which means "everyone gather together in peace". The performance was well received by all.

- Sister Lackie introduced Barbara Hill, an Aboriginal Elder. Sister Lackie indicated that Barbara Hill was born on the Kitigan Zibi Anishinabeg Reserve located outside of Maniwaki, Quebec and that she is a Drum keeper and a spiritual advisor to Nigaan. Barbara Hill opened the Convention with a traditional Aboriginal prayer.
- Sister Lackie introduced Brothers Cunning and Walsh and Sister Doucet who led the singing of 'Solidarity Forever'.

PSAC Statement on Harassment

Sister Lackie invited Sister Harding to read the PSAC Harassment Policy. A copy of the PSAC Statement on Harassment was provided in the Convention kits.

Our union is made strong by Sisters and Brothers working together to improve our working lives and to preserve the rights that we have struggled to achieve. Mutual respect is the cornerstone of this cooperation. The Alliance Constitution states that every member is entitled to be free from discrimination and harassment, both in the union and at the workplace, on the basis of age, sex, colour, national or ethnic origin, race, religion, marital status, criminal record, disability, sexual orientation, language, class, or political belief. Members are also entitled to be free from personal harassment.

If you experience harassment at this event, contact the identified Harassment Complaint Coordinator to discuss the situation and possible responses. Our initial approach is to encourage early and informal resolution and to facilitate our members speaking directly with one another to resolve the matter. If this is not successful or

possible, the Constitutional and policy mandates on the issue of harassment will be fully and quickly enforced.

Harassment in all its forms detracts from our common purpose and weakens our union. Let each one of us, as we work together on the important task at hand; treat each other with dignity and respect.

Sister Lackie then introduced Sisters Paulette Michon-Hamelin and Stephanie Ehler as the Anti-harassment Coordinators for this Convention.

PSAC Policy on Scent-Free Environments

Sister Lackie invited Brother Daniel Charron to read the PSAC Scent Policy A copy of the PSAC Scent Free Policy was provided in the Convention kits.

The Public Service Alliance of Canada is committed to ensuring that all members with disabilities are able to participate effectively in order to contribute to the organization's mandate.

In this regard, the Alliance recognizes that accessibility is an essential requirement for the participation of members with environmental disabilities.

In consideration for the health of our colleagues who may suffer from environmental disabilities, and with the goal of eliminating a contaminant from the air, the PSAC requests that all participants attending any union function refrain from using scented products. These include scented perfumes, colognes, lotions, hairsprays, deodorants and other products promoted by the fragrance industry.

The policy also requires that, before any union event or function, anyone suffering from environmental disabilities needs to self-identify with those organizing the meeting, course, or event.

A participant who notices a problem is required to address the person in a cordial and respectful manner. Any unresolved issues would then be brought to the attention of the organizers who will investigate and attempt to find suitable accommodation up to the point of undue hardship.

By working together, we can create healthier environments for ALL, and accommodate the needs of persons who have environmental disabilities.

Guest Speaker: Robyn Benson

Sister Lackie introduced Sister Robyn Benson, PSAC National President. Sister Benson was re-elected as PSAC National President at the 17th PSAC National Triennial Convention in May 2015. She was first elected as PSAC National President in May 2012. Sister Benson addressed the Convention delegates and thanked Sister Lackie for inviting her to speak at the GSU Convention.

As Sister Lackie will not be standing for re-election, Sister Benson extended her best wishes and thanked Sister Lackie for all of her hard work and dedication over the past six years. Sister Benson addressed the delegates and spoke about

the many challenges that the union is facing and by remaining united and strong we can make a difference.

Guest Speaker: Greg McGillis

Sister Lackie introduced Brother Greg McGillis, Regional Executive Vice-President for PSAC NCR. Brother McGillis was elected to this position in May 2017. He is best known as the primary instigator of actions related to Internet content under Section 13(1) of the Canadian Human Rights Act against people including white supremacists and neo-Nazis. He has been the successful complainant in sixteen consecutive cases before the Canadian Human Rights tribunal dealing with internet hate.

Appendix 'D' – Reports of the GSU National Officers

Report of the National President, Donna Lackie Government Services Union Seventh Triennial National Convention September 2017

As I now approach the end of my three - year mandate, I am amazed at how fast the time has passed. I can only attribute the passing of time to the immense amount of work we have completed, the large numbers of members we have represented through the GSU representation section, the support of the Miramichi Pay Center and our great members there, the successful federal court proceedings for the former CRA SP members, the technological policy grievance against TBS, support of our Locals across the country, national, regional and local representation with the employer....and the list simply goes on.

The political change to government in 2015 saw us move from the heavy hand of the conservative government and its attempts to impose aggressive restrictions on to the Canadian union/labour workforce, to this new Liberal government that made promises that have been slow to materialize, if at all. We are all too aware of the struggles of the PSAC Bargaining teams to complete collective bargaining which have all exceeded 3+ years of owed retroactivity payments, and the slow and disrespectful "signing" of those agreements, and now we are preparing to "re-enter" collective bargaining yet again next year. I want to encourage all of you to speak publicly about your jobs as Public Service Workers, talk about the quality public services that each and every-one of you provide with pride to Canadians each and every day. And most importantly, never hesitate to speak to your MPs and remind them that you expect early and engaged consultation with the employer in 2018, nothing less is acceptable.

The entire Pay Modernization/Pay Transformation project started more than 5 years ago and for all intents, was reasonably consultative and was the employer's efforts to provide optics of good labour/management relations. But for the most part, it was simply optics and ensuring they could report back to Treasury Board they were "consulting", when in fact, this was an aggressive project with unreasonable timelines and a huge political mandate to demonstrate costs savings in excess of 70 million dollars a year.

These costs savings would be the undoing of the Pay Transformation project, and result in the collapse of timely and appropriate delivery of pay. Our members in Miramichi, the majority of whom were all hired in Waves 1, 2 and 3, over the last 6 years, are all highly intelligent, skilled people who were provided training that defies reasonable. Training programs that were intended to be 18 months were reduced to

12 months and today we are seeing "Boot Camp" training being delivered that is only 6 weeks.

The actual processing of Government of Canada pay, is the most complicated pay in Canada, with more than 17 collective agreements, shifts, extra duty pays, cost of living allowances, and all of this payroll processing is being performed by GSU Compensation Advisors with less than a supportive tool – Phoenix.

I want to personally thank all of our members in Miramichi for their unwavering dedication to their clients, to the support of each other as Miramichi continues to evolve into the center of expertise for Government of Canada pay administration, and I am proud that I had an opportunity to support them over these last 6 years.

GSU National Office

At the center of every organization are the Brothers and Sisters who do the work of supporting the membership, the Locals and National Council. I am so proud of the dedication shown each and every-day by the entire GSU national office staff. Not only do they provide the necessary administrative support, but they "care" about the elected officers and volunteers within GSU. On many occasions over these last 6 years, I have witnessed GSU national office staff, going over and beyond what would be required to simply "help out" a member.

<u>Danielle Laprade</u>, <u>Tiffanie Francoeur</u>, both provide administrative support to the GSU National office, <u>Diane Turcotte</u> administratively supports the Representation Section, <u>Jennifer York</u> is responsible for GSU technology issues along with membership.

<u>Stephanie Ehler</u> and <u>Paulette Michon-Hamelin</u> support GSU members and Locals in matters relating to grievances and medical disability.

The GSU management team is comprised of Monique Desrosiers - Finances, Erik Gagné - Senior Representation, and Bob Haywood - National Advisor. This group has been instrumental in support of their sections, delivering day to day operations and most importantly, always being available to help out the locals, answer member's questions, or providing each of us with much needed technical advice and guidance.

And certainly not last, Sister Maria Thomas who is the Executive Assistant to the National President, and who has ensured that I am organized, kept current, prioritized issues, and kept us all accommodated when we travel, without her I would never have been able to do my job, I am truly thankful for her dedication. Maria is now the longest serving GSU staff member in the office and her corporate knowledge and experiences have kept us on track and focused on daily priorities.

GSU Finances

Under the supervision of Sister Monique Desrosiers, GSU finances have been provided with daily oversight and the required administration to ensure accurate reporting and accountability. Payables, receivables, payroll, investments form a part of the daily activities and responsibilities by the GSU Finance section.

Complying to acceptable Canadian accounting practices, Sister Desrosiers has ensured the appropriate reporting on all GSU financial matters.

Along with the GSU Finance Committee - Sister Martine Babcook, Sister Nicole Rousseau and Brother Bill Pleming to review all financial transactions, review of the GSU budget and to support the convention Finance Committee and recommendations and resolutions to GSU Convention.

GSU Pre-Convention Committees

Every three years, prior to the opening of the convention, GSU holds pre-convention committees for the purpose of prioritizing GSU resolutions to convention.

These committees meet to discuss resolutions submitted to convention, and to identify those resolutions with either "concurrence" or "non-concurrence". These committees discuss, and agree on the priorities to appear before the convention floor.

I am pleased to say, that we ensured that every member of GSU National Council and Local Presidents were appointed to these committees in an effort to ensure our discussions are of a national perspective. Although we do not have a large amount of resolutions submitted to convention, I am confident the discussions and the work of the committees will support the activities on the convention floor.

Government Services Union – Employers

Shared Services Canada

With a stabilization in the churn of delivery, SSC has now had an opportunity to reflect on its current organization, perform job classification reviews, organization changes, etc. and our members are starting to feel the department is approaching a normal level.

Regardless, we still have many issues relating to National Consultation vs Regional and now Branch Consultation is proceeding within SSC Nationally.

Recent classification review will also be positive and happy news for some of our members who have been immensely patient. We share a cooperative and supportive role with our Brothers and Sisters at PIPSC, and I want to encourage the new National Council to continue to build on that relationship as it supports both organizations and our memberships.

Royal Canadian Mint

The Royal Canadian Mint and its very stoic management have been the most challenging employer group to work with over these last 6 years. And while we had many gains at the bargaining table with the RCM, we also had challenges with bargaining certificates which resulted in us challenging the RCM to recover members who were performing in bargained positions not allocated.

The Royal Canadian Mint has a two-step grievance process and this has proven challenging for the GSU Representation staff, but the work and support provided by the Local Presidents and the Mint RVPs has gone a long way to support RCM members over the years.

I would encourage that all RCM elected officers continue to push the RCM to engage in a proactive consultative process with them and to support labour/management consultation.

Public Services Procurement Canada

All matters relating to Phoenix fall within PSPC and this has been the most stressful time for our members as a result of the Government of Canada's Pay Transformation. Not only are there pay issues for many public service workers but the community of Compensation Advisors, our GSU Brothers and Sisters, are working under immense pressure to ensure timely payroll every two weeks. The dedication of this incredible group of Compensation Advisors, working in less than ideal conditions with less than ideal "tools", surpasses any commitment that I have seen in my career.

But there are great successes within the Accounting, Banking and Compensation Branch (ABCB) branch and in particular the Pension Center in Shediac and the transfer last year of the Canadian Forces pension program to PSPC.

Real Property continues in its long term approach of divesting itself of its long held mandate of property management as it leverages the private sector to manage federal assets. With the recent hiring of a new A/ADM experienced in P3s projects, Real Property has set its course for the future both in its management of current assets and to the future of project management relationships.

Changes like; Workplace Renewal Initiatives, Novus, GCDocs, and Sigma, should all be powered down in an effort to not duplicate the results experienced by the aggressive release of Phoenix.

Branches such as Departmental Oversight, Human Resources Branch, CIOB, Finance all continue to work towards their mandates and represent hundreds of GSU members.

GSU Convention

Preparations for GSU convention at the end of September are fast approaching and the entire GSU component is working hard to make sure all of the details necessary are well under way. Travel plans, accommodations, committee work, preparing reports, it all takes a great deal of planning and doing. There is work to be done by all of us to ensure we have all of our work mapped out for us over the coming three years.

We have arranged for guest speakers, debates, and a few other surprises that we know you will enjoy.

In closing, I would like to thank all of you for your support over these last six years, for the leadership you have demonstrated in your regions, the commitment you have provided to your membership. This has been work that I have provided to the membership and am proud of where we are, given the challenges the employers threw in front of us at every turn.

To the incoming elected officers, prepare to work hard and always be available to the membership, GSU members deserve no less.

I would like to start off my report by saying I enjoyed my role as the RVP for Alberta, NWT and Nunavut for the last 3 terms. On October 26th I was acknowledged by the Western Region A/RDG and the RD's for my partnership and commitment to the development of a strong and positive union-management collaboration in the Western Region. I was awarded a Level 6 Iboutique award which I'm very honoured to get as I am the first GSU member to be recognized by the employer in this way.

Since becoming NVP in July of 2016, I have continued to be part of the National Health and Safety Policy Committee which meets in Ottawa quarterly. On February 11 and 12, 2017 PSAC had a National Health and Safety Committee Forum for members who sit on their employers NHSPC.

I also attend the National Labour Management Consultation Committee which meets quarterly and is Co-Chaired by the Deputy Minister and the 4 Unions representing members. The main issue in all the meetings I have attended is Phoenix and the Unions voice their frustrations. I had some Phoenix issues brought to me in the Western Region and some have been fixed but others continue to be in limbo. The biggest pay issue we have in the Northern Region is the Vacation Travel Allowance. Some members were not getting the VTA and it was causing them an enormous amount of stress as they count the VTA as part of their compensation package for living in the Northern Communities.

I Co-Chair the CIO Branch meetings for the members and the ongoing topics of discussion include Talent Management and Mental Health Strategies. I also Co-Chair the Acquisition Branch Meeting along with the ADM Lisa Campbell. We met for the first time in October and some of the topics we discussed are Workplace Wellness Indicatives and Succession Planning.

I am also the Co-Chair of the GSU Finance Committee. We meet quite often and when I'm in the GSU office I meet with Monique Desrosiers and we also communicate by phone and email on a regular basis. I would like to thank Brother Jack Gale as outgoing Chair for all his leadership in this committee. Brother Bill Pleming and Sister Nicole Rousseau are also part of the GSU Finance Committee.

September 2014 – September 2017

Brothers and Sisters, I was absolutely honoured to have served as the National Vice-President – Equity for the past three years. It has been a busy 3 years filled with lots of change and challenges, but it has also been very productive and rewarding as well.

My portfolios over the past three years have included; consultation with Public Services and Procurement Canada including: Accounting, Banking and Compensation Branch; Real Property Branch; National Labour Management Consultation; National Health and Safety Policy Committee; Joint Committee on Employment Equity and Diversity (JCEED); National Diversity Network. With Shared Services Canada I have participated at times in the National Joint Consultation Committee Meetings; and I have consulted with the department on Employment Equity and Diversity. With the Royal Canadian Mint, I have consulted with the employer on Equity and Multiculturalism issues. I am the chair of the GSU Equity Committee, the chair of the GSU Local Development Committee and the interim chair of the Young Workers Committee. I am the bargaining agent co-chair for the Federal Informal Conflict Management Network on behalf of the PSAC.

In addition to my portfolios I have worked on several joint subcommittees with PSPC. In 2015 the GSU Equity Committee submitted a recommendation to National Council that this kind of training be given to all our leadership so they might better represent all our membership. I would like to thank all past and present members of the GSU Equity Committee for their engagement and participation in working to forward the equity agenda for all of our members.

Although Local Development was extremely busy, the committee did not meet often. We met once in person and a few times via phone or email. The locals that were identified for

local development were in dire need of training or intervention of some sort and often the need was immediate. I worked extremely closely with Brother Bob Haywood and the GSU National Office in organizing training that would fit the immediate need of those locals. Although the members of the committee were not as involved as they probably should have been, this kind of local development is really best developed in consultation with the RVP of the local concerned and the Local Executive. My apologies to Sister Melanie Hamel and Brother Sheldon Jacobs for not utilizing the committee in a better, more inclusive way. I thank you both for your participation and contributions that you did give to the development of our locals. There were 6 locals identified over the past 3 years and we had the time to work with 5 of those 6. The needs of each local were unique and I believe we managed to help address the issues that were presented and provide guidance or training for the executive members who required it.

After the last convention I was tasked with looking at the feasibility of having a GSU Young Workers Committee. In 2014/2015 I did some research and worked with Sister Jennifer York and Brother Bob Haywood to look at our membership composition and see if it was feasible to have a Young Workers Committee, I presented my findings to National Council in May 2015. Council requested I continue with trying to get a Young Workers committee established. In 2015/2016 we ran a contest to try to engage the Young Workers in GSU but only about 30 Young Workers participated over the 4 weeks of draws and of that, less than half participated in a short survey trying to gauge interest in a GSU Young Workers Committee. Of those numbers only a handful said they would be interested in being part of a committee. You will notice there is a resolution in regards to the GSU Young Workers... it is imperative that we get direction from the convention floor in regards to officially striking a committee and putting funding towards that. It will be up to the convention if this proceeds over the next 3 years.

As NVP-Equity I have had the privilege of attending many Local AGMs on behalf of GSU and of representing GSU and various committees within PSAC and with the employer. I always research and come prepared but I also take the time to consult with members who belong to the area where I am going to be representing in order to ensure I am presenting factual and current information and issues. I have also had the opportunity to represent GSU at some of the PSAC National Board of Directors meetings in Donna's absence.

Some other duties of the NVP-Equity included sitting on convention committees for the PSAC. Pouring through reports, recommendations and policies in order to give feedback that would be incorporated either with the employers or with the PSAC. Being asked to attend meetings sometimes with very little notice. Ensuring I had a working knowledge of all our employers in order to best represent our members. Taking online education and in person training to stay on top of the PSAC's curriculum. Participating in PSAC Forums in the areas that I hold responsibility.

One of the biggest challenges I have faced during this cycle was the absolute frustration with some of the National Consultation. Advising the union of a decision or direction that has already been done a day prior to roll out is not Consultation. We have seen some improvements on this in some areas, however with the constant change in leadership we have to "retrain" those new leaders on what true Consultation is.

One area I hold most hope for is the current direction with ABC Branch in regards to our members at the Pay Centre. After years and years of us talking about the human impact this botched pay system is having on our members, it seems that the new ADM and Directors have heard us and have plans to start implementing programs and initiatives to help relieve some of what we have been raising. Time will tell, but after our last consultation meeting I feel very hopeful.

I feel extremely lucky to have found a place within GSU to serve our membership and continue to learn and grow in my own leadership. I hope I have served you well.

GSU National Council has seen a lot of turn over during the past 3 years, both with NVPs and with RVPs, I have appreciated working with all of you and look forward to working great with the new council in years to come.

I would be remiss if I didn't acknowledge Brothers Jack Gale and Bob Cameron both of whom contributed greatly during their time as National Vice Presidents. It was difficult to see them leave before their terms were complete as they worked hard on their portfolios and contributed so much to our members and organization. They both have been mentors and friends to me and I wish them the best in their next chapters.

I wish to take the time to thank Sister Martine Babcook for serving as my fellow NVP for the past year, it has been a pleasure working with you. I would especially like to thank the staff at GSU National Office, your knowledge, assistance and dedication to our membership is amazing.

Finally, some words about Sister Donna Lackie. When you first ran for the position of National President I was a Local President and I was a fierce advocate for you. I lobbied on your behalf and let everyone know who I was supporting. Last convention I had the pleasure of voting for you again when I was Regional Vice President.

I have appreciated the opportunities and mentorship you have also provided to me as a leader. I wish you the very best in your next chapter, no one can deny your commitment to our membership over the past 6 years you have served as National President. Congratulations and enjoy your retirement.

I would like to thank the membership for electing me to this position and I hope to have the honour to serve you again over the next 3 years.

Appendix 'E' – Ratification of Regulations and Policies to the GSU Seventh Triennial Convention by National Council

REGULATIONS

Regulation 1: Regions for Regional Vice-presidents - be amended to include the following changes: the Pacific Region second bullet-delete **remainder of BC and Yukon** and include Vancouver Island, the remainder of British Columbia and the Yukon Territory.

Regulation 2: By-Law 9, Section 2g

A quorum for any General Membership Meeting, including the Annual General Membership meeting, shall be a majority of the Local Executive Committee and at least members. (The Local shall set a specific number or percentage or combination, as determined by the Local).

At minimum, a quorum for any General Membership meeting including the Annual General Meeting shall be:

- The majority of the Local Executive Committee; AND
- Local members in good standing, equal to the number of positions within the Local Executive plus 1.
 - e.g. If the Local Executive Committee consists of 6 members, the minimum quorum shall be 11(4+6+1).

To further illustrate this proposal, please refer to the examples below.

Locals with:

- 6 Executive Committee members (majority = 4) + 7 members in good standing = 11 for quorum.
- 5 Executive Committee members (majority = 3) + 6 members in good standing = 9 for quorum.
- 4 Executive Committee members (majority = 3) + 5 members in good standing = 8 for quorum.
- 3 Executive Committee members (majority = 2) + 4 members in good standing= 6 for quorum.

For GSU Locals with less than 50 members quorum reads as follows:

At minimum, a quorum for locals with less than 50 members for any General Membership meeting including the Annual General Meeting shall be:

- The majority of the elected Local Executive Committee; and
- Local members in good standing.

Regulation 3: Terms and Conditions of Employment for the National President:

Section 4: Continuous employment:

Delete severance pay.

Section 10a: Vacation leave with pay:

- a) For each calendar month in which the National President earns at least ten days' pay, he or she shall earn vacation credits with pay at the rate of:
 - 1 ²/₃ days if the Officer has completed less than 18 12 years of continuous employment.
 - ii) 2 ¹/₁₂ days if the Officer has completed **18 12** years of continuous employment.
 - iii) 2 ½ days if the Officer has completed **25 20** years of continuous employment.
 - iv) After having completed 22 years of continuous employment, the President shall be credited with one-half (1/2) day of vacation leave for each successive year of continuous service to a maximum of five (5) additional days of vacation leave.

Section 10 c:

Carry over of vacation leave credits is permitted but shall not exceed one year two year's entitlement.

Section 10 d:

Vacation leave credits with pay exceeding one year two year's entitlement not used on December 31st each year will be paid in cash at the rate of pay received by the Officer on December 31st.

Section 15: Other benefits:

The National President is entitled to all other benefits that are currently applicable to employees of the Alliance Employees Union (AEU) Union. Any changes to benefits for AEU Union employees shall be reviewed by the National Council before being applied to the National President.

- Salary Continuance Insurance Plan
- Hospital and Medical Insurance
- Employment Insurance
- Workers' Compensation
- Canada Pension Plan

Section 17: Severance Pay

The National President shall, on termination of office, be entitled to be paid one (1) week's pay at the position's current rate of pay for each completed year of continuous employment with the Government Services Union.

Regulation 6: Life Memberships, and Honourary Memberships and Awards of Merit

<u>Section 2c:</u> All Life members who are no longer delegates to Convention, are invited to attend GSU Conventions at their own expense.

<u>Section 2d:</u> A list of current GSU Life Members will be maintained by the National President and will be published in the booklet with a short biography containing the GSU By-laws.

<u>Section 2g:</u> The Life member will receive a GSU gift of their choice (maximum of \$200). If photos are taken of the nominees, they become the property of the National Office for use at its discretion.

<u>Section 3c:</u> A nomination for GSU Life Membership must be made using the GSU Life Membership Nomination Form. Nomination Forms may be downloaded from the GSU Website or obtained from the GSU National Office. All applications for Life Membership shall be referred to the GSU Union Recognition Committee. The Committee will review all applications and make appropriate recommendations to National Council.

Section 3d: add voting will be done by secret ballot.

<u>Section 4 a</u>: delete other than the <u>Local and which in person held</u> membership.

<u>Section 4b</u>: add be reviewed by the Union Recognition Committee and if approved

Section 4c: add and voting will be done by secret ballot

<u>Section 4f</u>: Honourary members will receive a plaque. The award shall be presented at a Local or National event by a Union Official. If photos are taken of the nominees, they become the property of the National Office for use at its discretion

Section 5c: add and voting will be done by secret ballot

<u>Section 5e</u>: The recipients will receive a plaque. The award shall be presented at a Local or National event by a Union Official. If photos are taken of the nominees, they become the property of the National Office for use at its discretion

Regulation 10-Replacement of the National President-

Section 1. Vacancy due to Absence

Each National Vice-president will be delegated to act for the National President on a rotational basis. The order of rotation will be based on the number of votes received by each National Vice-president during their election at Convention with the officer receiving the highest number of votes acting first. Each NVP will be so delegated for one year.

Regulation 13- GSU Elected Officer be deleted.

As an elected officer, I am a volunteer. When I accept the responsibility of elected union office, I also accept that I am accountable to carry out the duties of that office.

Upon taking the oath of office, I will:

fulfill the duties assigned to me by GSU By-laws, the National Council, the National President, and other authorized bodies;

promote and implement GSU principles in my work as a union officer; obtain the training and education appropriate to my elected office; acquire knowledge of the issues important to the members in my jurisdiction; act in a respectful and courteous manner as a representative of this union; and take ownership of the decisions I make in my elected position.

POLICIES

<u>Policy 3:</u> Family Care at GSU Meetings- part c is amended as follows: Where quality family care is not provided or where it is not convenient or economically feasible to bring family members to these facilities, those members requiring assistance will be <u>paid the amount of twenty –five dollars (\$25.00) per day or such greater amount as determined to be reasonable by the National Council for family care costs connected with the event. This amount will be claimed by completing the appropriate section on the expense claim form and attaching appropriate receipts. reimbursed according to the PSAC Family Care Policy.</u>

Policy 15: Local Annual General Meeting Subsidy

An allowance of \$100.00 per year will be provided to GSU Locals with fewer than 100 members to help offset the costs of holding the Annual General Membership

Meeting. Each qualifying Local must apply for the subsidy each year, in writing to the National President.

FIVE NEW POLICIES ARE ADDED:

Policy 17: Signing authority for Memorandums of Understanding

All elected officers of GSU must submit to the GSU National Office, Representation section all MOUs requested for signature by the employer. GSU legal/representation section will review these MOUs to ensure nothing is contained that would pose future impacts on our members should they wish to challenge the MOU.

This policy applies to all elected GSU officers and any member representing on behalf of another member.

Policy 18: Recognition of Prior Memberships

Associate Memberships, Honorary Memberships, and Life Memberships recognized by the former Supply and Services Union and the former Union of Public Works Employees, which are compatible to the membership in this By-law, shall be recognized by this Union.

<u>Policy 19:</u> GSU Awards and Bursaries / PSAC Awards Process In the Spring of every year, a notice will be sent to the National Council and Local Presidents advising them of the GSU and PSAC Awards Program. The process will be posted on the GSU and PSAC websites respectively.

The PSAC National Board of Directors (NBOD) has established criteria to govern the granting of PSAC long-term service pins and certificates.

The awards seek to recognize long-term officers of the union at any level who have continuously served the membership. Criteria and applications forms can be found on the respective websites.

Policy 20: Equity Training at all GSU Leadership Events

GSU will provide Equity Training at all events where GSU Leadership is participating with the intent to ensure that Local Presidents, Regional Vice-presidents, National Vice-presidents and the National President are open to all our members and aware of some of the challenges that our equity members face.

Policy 21: Translation of Local By-Laws

GSU will pay for the translation of each Locals' By-Laws to ensure they are in both official languages. Following their translation GSU will ensure the Locals' By-Laws are posted on the website.
